INSURANCE

We require that you provide a copy of your insurance for a minimum of \$1M, listing "**Douglas County, The Douglas County Board of County Commissioners, Minden-Tahoe Airport, and the employees, officers and contracters of Douglas County**" as additionally insured.

All expenses related to the Aviation Roundup Open House will be the responsibility of the individual. Food & beverage vendors are responsible for all necessary permits.

**FEES**

Merchandise vendors will pay a fee of \$300 plus 15% of gross sales. The 15% will be paid at the end of each day.

Non-Profit vendors will pay a fee of \$150.

Non-Aircraft Display vendors will pay a fee of \$300.

**Fees are for a 10' x 10' spot.** Each additional 10' is \$100. Example: 10' x 20' = additional \$100.

Vendor fees include 4 vendor passes per day. Additional passes must be purchased separately.

**Due to the limited availability, a *non-refundable deposit* of \$100 is due with this application. This fee will not be refunded if the vendor cancels. The balance of the vendor fee is due upon arrival prior to setup.**
